CONDITIONS OF ENTRY

1. Competitor must be 13 years of age and under as at the 31st December in the year of the scholarship.
2. Competitor must have passed the following grades:
 - a) Primary Cross
Bronze Cross
Silver Cross with Highly Commended or higher
3. Competitor must have been studying with the studio owner listed above for the previous Calendar year. The Competitor must be enrolled and participating in classes at the school stated on the entry form in order to perform on the day of either the State or Australasian Scholarship. **Refer to State and Australasian Scholarship Rules located in the Scholarships section of the website*
4. The Scholarship entry form must be signed by the studio owner, the competitor and their parent/guardian and must be accompanied by the following:
 - a) Copy of birth certificate/extract, passport or other legal document;
 - b) Copies/A.T.O.D. computer printouts of all examination results required for the entry qualification as above.

DANCE REQUIREMENTS

1. All competitors will participate in an unseen class prior to the stage performance.
 2. The competitors will perform the following two dances on stage in full costume:
 - a) National Character Dance (2 min max). This may be the Primary, Bronze or Silver Cross exam dance or a variation of or the teacher's own choreography (must be authentic)
 - b) National Character Dance (2 min max). This is teacher's own choreography and must be a different country to the one danced in (a). This dance may be repeated in the Junior or Intermediate Ballet Scholarships. (must be authentic)
- Studio Owners, Teachers, Parents and other interested parties must not approach or have any contact with the Adjudicator whatsoever.
 - The Adjudicators decision is final and no correspondence will be entered into regarding their decision.
 - All competitors participate in the scholarship at their own risk.
