4. The Scholarship entry form must be signed by the studio owner, the competitor and their parent/guardian and must be accompanied by the following:
a) Copy of birth certificate/extract, passport or other legal document;
b) Copies/A.T.O.D. computer printouts of all examination results required for the entry qualification as above.

- 1. The competitors will perform the following dance on stage in full costume:
a) 4/4 any tempo (1.5 minute maximum): This includes but is not limited to Traditional and Street Styles. Music with or without lyrics may be used.
