1. Competitor must be 17 - 21 years of age as at the 31<sup>st</sup> December in the year of the scholarship.
2. Competitor must provide 3 of the following; including at **least 1 of the qualifying** grades as listed below:

- Level 8
- Level 9
- Level 10 with Commended Plus or higher (Qualifying)
- Level 11 with Commended Plus or higher (Qualifying)
- Level 12 with Commended Plus or higher (Qualifying)

3. Competitor must have been studying with the studio owner listed above for the previous Calendar year. The Competitor must be enrolled and participating in classes at the school stated on the entry form in order to perform on the day of either the State or Australasian Scholarship. *\*Refer to State and Australasian Scholarship Rules located in the Scholarships section of the website*
4. The Scholarship entry form must be signed by the studio owner, the competitor and their parent/guardian and must be accompanied by the following:
  - a) Copy of birth certificate/extract, passport or other legal document;
  - b) Copies/A.T.O.D. computer printouts of all examination results required for the entry qualification as above.

**DANCE REQUIREMENTS**

1. All competitors will participate in an unseen class prior to the stage performance.
2. The competitors will perform the following two dances on stage in full costume:
  - a) Lyrical Hip Hop (2 minute maximum): This includes but not limited to music that is slow tempo, down tempo Rap or R&B music. It is a fluid or interpretive version of standard Hip Hop.
  - b) Up tempo (2 minute maximum): This includes all Street style music & choreography, excluding Lyrical Hip Hop. Included but not limited to Urban, Commercial, House, Popping & Locking, Breaking etc.

- Studio Owners, Teachers, Parents and other interested parties must not approach or have any contact with the Adjudicator whatsoever.
- The Adjudicators decision is final and no correspondence will be entered into regarding their decision.
- All competitors participate in the scholarship at their own risk.
